PROCESS STAGE	POTENTIAL RISK	CONTROL MEASURES	ACTION REQUIRED
DELIVERY			
Packaged in 12 x 400 ml metal, aerosol, pressurised, canister sprays. Delivered in single units if required.	Risk of injury to user if dropped.	Trained employees should handle only single containers at any given time. Take care not to drop the containers. Ensure that the cap is always secure.	Transfer container to store immediately following delivery. Do not leave containers in areas where users of the building will come into contact with them.
STORAGE			
Containers must be stored in a cool, dry storage area away from sources of heat, including direct sunlight.	Extremely flammable. Pressurised canister – therefore there is a risk of explosion if involved in a fire or if punctured. If involved in a fire, carbon oxide gasses may be emitted. Caps are not child proof.	Keep containers in secure storage areas. Store all containers below chest height to minimise risk of dropping. Restrict access to storage areas to authorised personnel. Keep away from sources of heat.	Use oldest stock first. Make regular checks to ensure that storage area is clean and tidy. Make regular checks to ensure that canisters are sound and are not corroded.
USAGE			
Product is dispensed in a fine mist via a push top spray. Product is applied directly onto the surface to be treated from a distance of 10–30cm.	Risk of severe skin and eye contact and damage. Risk of ingestion. Risk of inhalation.	Handle the containers with care. Wear Personal Protective Equipment for prolonged use only. Spray product away from the body and face at all times. Ensure that the container is returned to store when not in use. Ensure that work area is well ventilated at all times. Never spray near sources of heat or incandescent material. Always read the manufacturer's instructions.	Provide employees with PPE as follows: • Protective Gloves • Safety Goggles Ensure that operatives are aware of location of First Aid facilities. Ensure that operatives are aware of all fire procedures.
DISPOSAL			
Empty canisters can be disposed of as normal waste. Recycle all containers wherever facilities are available.	Small risk of skin or eye contact. Small risk of inhalation and ingestion. Risk of contamination with other substances.	Ensure that the canisters are exhausted prior to disposal. To dispose of residual stock, empty product via spraying outside in an open space. Do not puncture or incinerate even when empty.	Ensure that all operatives wear Personal Protective Equipment at all times during disposal. Ensure that all operatives are aware of the First Aid equipment.
